WHEREAS, *Section 11-46-27 of the Alabama Code, 1975*, as last amended by *Act 2003-400*, provides that the municipal governing body or a majority of them must, not less than fifteen (15) days before the holding of any municipal election, appoint from the qualified electors of the respective wards or voting district, officers to hold the election as follows: where voting machines are used, an Inspector, a Chief Clerk, a First and Second Assistant Clerk for each voting machine; and


